MAIN CASE

2. Report No.120 has been filed by the Members of the Judicial Water and Environmental Commission and refers to the steps taken by the Commission with regard to installation of waste water treatment plants. Report gives an overview of the action taken in respect of industrial units which shall continue as these constitute important steps towards preserving the ground water of Lahore. With regard to traffic congestion it has been stated in the report that a meeting was conducted on 28.02.2022 in which various issues regarding traffic congestion were discussed and further report shall be submitted on the next date of hearing by the Members of the Commission. Also a letter has been written to the Chief Secretary with regard to Qingqi Rickshaws and for implementation of the Supreme Court's judgment reported as 2017 SCMR 1098. Report has also been submitted regarding rooftop gardening and according to the Members of the Commission meetings are taking place in this regard and final report shall be submitted on the next date of hearing.

3. Report on behalf of Metropolitan Corporation Lahore has also been submitted which refers to the progress regarding anti-encroachment activities. It is directed that these measures shall continue to be put in
