Learned Members of the Commission have informed that waste water treatment plants have been installed by Shan Food's and an affidavit in this regard has been submitted regarding progress report. EPA shall file a final report after serving of samples of the treatment plant. A meeting was also held regarding recharge wells and a further report shall be submitted on the next date of hearing. It is also informed that rescue 1122 has been engaged for the purpose of lifting water from the ablution tanks for their use. It is directed that if

the water is fit to be used it shall be done firstly for irrigation of parks and plantations in the nearby parks and greenbelts. Further progress of PHA with regard to greenbelts has also been placed on the record according to which Miyanwaki Urban forest in the vicinity of Samasani graveyard, Johar Town has been prepared and sent to the competent authority for approval. Further green areas behind Emporium Mall have also been fitted with tiles and progress is underway for reclaiming of that area so that greenbelts can be restored. With regard to plying of school buses, a meeting was held and a further report shall be filed on the next date of hearing.

- 2. Learned counsel for LDA informs that applications for registration of FIRs against persons who were found tempered with sealing orders of LDA are pending with different police stations. The DIG (Operations) Police Lahore is directed to ensure that these applications are followed up. Prior to that, however, the persons against whom FIRs are sought to be registered must be called and in case they ensure the compliance of the orders for installation of rooftop gardening/solar panel, further actions must be deferred subject to an undertaking.
- 3. The Chief Traffic Officer has informed that a further 500 cement barriers are required by the traffic

police for managing the traffic congestion in various parts of the city. This requisition shall be placed before the Chief Engineer, TEPA who shall ensure that cement barriers are provided to the City Traffic Police as was done previously and which ensured the smooth operation of traffic flow in the city.

- 4. Learned counsel for PHA has also filed a report which mentions certain actions which have been taken by PHA. It is also informed that Mr. Ali Nawaz, Director PHA shall serve as focal person to liaison with the Commission. A comprehensive report shall be filed by PHA on the next date of hearing as to the steps which are to be taken as a policy by PHA and in respect of which directions can be issued by this Court.
