MAIN CASE

5. Report No.60 has been filed by the Chairman, Judicial Water Commission with regard to the approval of the budget for provision of Lorries. Learned A.A.G shall seek instructions from the Secretary Finance as to what is the impediment in the way of approval of the budgetary allocation for the purpose of these Lorries. This shall definitely be placed on the record.

6. Also Water Commission has appointed Mr. Akbar Nasir Khan, DIG/C.O.O. PSCA as a focal person. His appointment is approved and the said officer shall act as a focal person in all the matters within remit of Water and Climate Commission.

7. Deputy Director, EPA has also apprised this Court that the directions issued with regard to the disuse of polythene bags is also being complied with and a report shall be submitted on the next date of hearing. It is reiterated and directed once again that all stores and bakeries especially with regard to stores which are dispensing eatable items will be barred from using

polythene bags in future and at end of the period given by this Court. This should make themselves compliant of prohibiting the use of polythene bags after the period comes to an end. This order shall also be conveyed to all the major hotels in Lahore to which a time of two weeks is given within which compliance shall be made. Similarly, the EPA shall convey the order to all shopping malls of Lahore to stop the use of plastic bags. They shall make themselves compliant within two weeks thereof.

8. Report on behalf of Water Management Wing of Agriculture Department has also been submitted which is placed on the record.

9. Mr. Salman Akram Raja Advocate and other counsels appearing on behalf of the bottling companies undertake to file a report on the next date of hearing to show the way as to how plastic bottles will be dealt with. This shall be done on the next date of hearing.
