2. A report has been filed on behalf of the Chairman Water Commission. In that report, it has been pointed out that a combined affluent treatment plant is being set up in Sundar Industrial Estate. However, the learned counsel points out that a chunk of land was earmarked for setting up the treatment plant in Sundar Industrial Estate and it is apprehended that that land may be used for some other purpose. It is directed that the land earmarked for setting up the affluent treatment plant shall not be used for any other purpose during the pendency of this petition before this Court.
