Learned counsel for the petitioner in connected matter Mr. Sheraz Zaka, Advocate has produced a notification dated 14.10.2020 in which smog has been declared as a calamity under Section 3 of the Punjab National Calamities (Prevention & Relief) Act, 1958. The Director General, PDMA is present in the Court as directed during the proceedings in the morning. He has not been able to present the Court any tangible steps which were taken pursuant to the notification by which smog was declared as a calamity. It is clear that there are no follow-up steps that have been put in place by PDMA for dealing with the calamity and it is insufficient for smog to be declared as such unless substantial measures are taken in this regard. It is imperative, therefore, for the PDMA to come up with extensive plan to deal with menace of smog and for the purpose a meeting shall be held under the chairmanship of Water Environmental Commission appointed by this Court. The Director General PDMA, Commissioner, Lahore as well as Director General, EPA shall attend the meeting and come up with a plan to deal with the problem of

smog which has virtually engulfed Lahore currently. That plan will be placed before the next date of hearing.

Also under the Punjab Environmental Protection 2. Act 1997, the Environmental Protection Council has been constituted whose Chairman is the Chief Minister Punjab. In view of the prevailing condition of Lahore and its adjoining areas, it is all utmost importance that the meeting of the Council be convened at the earliest by the Chief Minister, Punjab to deliberate upon the calamity of smog and to issue direction for effectively dealing with the situation on urgent basis. It is directed that the meeting of the Council shall be convened and held within this week and a report shall be filed by the Secretary to the Chief Minister, Punjab before the next date of hearing. Learned Additional Advocate General Mr. Anis Ali Hashmi Advocate shall coordinate holding of the meeting of the Committee constituted above Chairmanship of the Water Environmental Commission.
