mentioned in the letter dated 16.12.2022. Further, as directed on the last date of hearing, summary shall be moved by the EPD for procurement of PTZ Cameras as suggested by the Deputy Commissioner, Lahore. The Members of the Commission shall also contact the Punjab Green Development Fund for diversion of funds towards acquisition of PTZ Cameras as well as super seeder to control stubble burning. According to the officers of EPD, draft rules have been circulated to different departments for their comments and a meeting is scheduled to be held tomorrow. Further report shall be submitted on the next date of hearing in this regard. The Deputy Commissioner has also submitted a report regarding different issues according to which drone cameras and PTZ cameras ought to be procured in order to have a better evaluation of the situation on the ground regarding violating industrial units and the use by them of substandard fuel.
