Report No.116 has been field by the Members of the Judicial Water and Environmental Commission according to which NOCs in respect of three sugar mills have been issued by the EPA and in respect of other sugar mills it will be done shortly a stated by EPA. Also

two sugar mills have installed waste water treatment plants and the rest are in different stages of installation.

- 2. With regard to the holding of PSL, it has been informed that further issues are being resolved with regard to the security etc for which a meeting is due to take place between the members of the relevant officers of the Provincial as well as Federal Government and a report shall be submitted on the next date of hearing. Regarding drain water management at Qaddafi Stadium a meeting is called in which various issues highlighted in the order dated 26.01.2022 will be taken up for consideration.
- 3. With regard to installation of water meters a project brief has been submitted by WASA according to which the concession agreement signing tentative date is 10.02.2022 and it is likely that the project under the public private partnership of the installation of water meter shall start in September this year after which water meters shall be installed in Lahore and which will go long way in curtailing the use of water.
- 4. Report regarding smog has been submitted on behalf of LWMC but it is informed that the burning of garbage is continuing unabated and which needs to be checked. The Chief Executive Officer, LWMC shall file a proper report regarding steps taken with regard to this



problem. Also proper notice shall be issued to all the employees of LWMC stating specifically that in case burning of garbage takes place that employee shall be penalized under the relevant laws. Further the LWMC shall place on the record suggestions regarding imposition of fine for throwing litter and garbage by the general public.

- Learned counsel for LDA has placed on the record 5. report according to which LDA sub-committee has approved various schemes of road renovation/repair/improvement for the a number of works in respect of which tendering is under process. Further learned counsel informs that regulations are being amended in order to make them in conformity with the requirement of rooftop gardening etc. It has been informed by the learned A.A.G who contacted the learned Judicial Magistrate dealing with LDA and MCL matters that he holds his court in District Courts. It is directed that the learned Magistrate shall deal with the matters relating to LDA and MCL for at least two hours per day exclusively and this shall be continued for five days.
- 6. Report has been filed on behalf of the commissioner, Lahore Division which is handed over to the Members of the Commission who shall look into it.
